Team members must be present and registered at the registration table by 9:30 am on May 1, 2016 for final instructions and tournament rules. Team will forfeit its place should team members fail to register and appear on time. The players must be continuously present for the duration of the competition and abide by all tournament rules given at registration.

Note: Denio's Management reserves the right to disqualify any team for any reason without explanation. Tournament officials may modify rules at their discretion.
